## MARINE CIRCULAR 1/2025

**TO** Ship Owners, Ship Managers, Ship Operators, Ship Masters, Ship Officers

**SUBJECT** Endorsement/recognition of Foreign Maritime Administration' Certificates of Competency

### PURPOSE

This Marine Circular provides the list of foreign maritime administrations whose COCs are recognized for endorsement by Kiribati in accordance with STCW I/10.

### DEFINITIONS

The following abbreviations stand for:

- "STCW" - International Convention on Standards of Training, Certification and Watchkeeping for Seafarers, 1978, as amended
- "COC" - Certificate of Competency issued under STCW
- "COE" - Certificate of Endorsement / Recognition as per STCW I/10
- "OOW" - Officer in charge of a Navigation Watch
- "OEW" - Officer in charge of an Engineering Watch

The term "**Administration**" refers to the Kiribati Ship Registry.

### APPLICATION

This Circular applies to all ship officers serving on Kiribati-flagged ships.

**RECOGNITION OF COCs BY FOREIGN MARITIME ADMINISTRATIONS NOT**  
**LISTED UNDER KIRIBATI MARINE CIRCULAR 1/2025**

1. In addition to the documents specified in Section C 3.5.3 of Kiribati Registry Circular RC/5/2012, applications for Kiribati Crew Endorsements for officers who hold STCW CoCs not listed under Kiribati Marine Circular 1/2025 will be required to submit sea service record according to the table below.
2. Notwithstanding the above, the Kiribati Administration reserves the right to not recognize STCW CoCs that are not listed under Kiribati Marine Circular 1/2025.
