MARINE CIRCULAR 3/2025

TO : Ship Owners, Ship Managers, Ship Operators and Recognized Organizations

SUBJECT : IMPLEMENTATION OF INVENTORY OF HAZARDOUS MATERIALS (IHM)

PURPOSE :

This circular provides information relating to the implementation of the **HKC** and instructions on issuance of **SoC-IHM** and Part I of the **IHM**.

- HKC The Hong Kong International Convention for the Safe and Environmentally Sound Recycling of Ships, 2009
- IHM Inventory of Hazardous Materials
- ITC 69 International Convention on the Tonnage Measurement of Ships, 1969
- PSC Port State Control
- RfRC Ready for Recycling Certificate
- RO Recognized Organization as defined by IMO Resolution A.789(19)
- SoC-IHM Statement of Compliance on Inventory of Hazardous Materials
- SRR Ship Recycling Regulation

The term "Administration" shall mean the Kiribati Ship Registry.

APPLICATION:

- 1. This circular applies to Kiribati-flagged ships of 500 GT and above including:
 - 1.1. New ships (built on or after 26 June 2025)
 - 1.2. Existing ships (by 26 June 2025). After the date, ships preparing for recycling must carry a valid RfRC.
 - 1.3. Ships calling a State party to the **HKC**.
- 2. By 25 June 2030, all existing Kiribati-flagged ships must:
 - 2.1. Have an approved IHM Part I, II & III,
 - 2.2. Hold a valid SoC-IHM, and
 - 2.3. Be ready for recycling compliance if applicable.

CONTENTS

3. Certification Requirements

- 3.1. All applicable ships must carry a valid SoC-IHM issued by RO.
- 3.2. Ships calling EU ports must comply with both HKC & EU SRR (EU SRR No. 1257/2013).
- 3.3. Separate SoCs should be issued for HKC and EU SRR where applicable.

4. Action Required

- 4.1. Shipowners, managers and ROs are to ensure IHM certificate and maintenance is done as per MEPC.269(68).
- 4.2. ROs may issue SoC-IHM upon request after completion of required surveys.
- 4.3. IHM must be updated and maintained during the ship's life.
